Action Requested:	Review information, deadline dates, regarding administration and payment of the PSAT/NMSQT for the 2018-19 Academic Year

Brief Explanation:

All district students in grade 10 are expected to take the PSAT/NMSQT. Sites may also elect to permit students in grade 11 to take the PSAT/NMSQT.

PSAT/NMSQT exams cost \$16.00 each. The district will provide funding for the PSAT/NMSQT for students in grade 10. The district will not cover the cost for these exams for students in other grades. Fee waivers are available for eligible students in grade 11. Grade 11 students who qualify for free and reduced lunch are considered income-eligible and are eligible to receive a fee waiver that will cover the \$16.00 exam fee. School sites are responsible to request fee waivers by the fee waiver deadline, Friday, June 29, 2018.

On October 10, 2018, the College Board will provide the PSAT/NMSQT for school site administration. These exams are aligned with the SAT. The exams will give students access to free personalized SAT study. With students' explicit permission, Khan Academy will use their PSAT/NMSQT results to develop individualized SAT study plans.

PSAT/NMSQT Related Content

- All of the assessments included in the SAT Suite of Assessments are connected by the same underlying content continuum of knowledge and skills. As students progress from grade to grade, the tests will keep pace, matching the scope and difficulty of work found in the classroom. The assessments have been designed to connect directly to instructional concepts in the classroom and daily practice, and this guide and related resources provide support as you engage in instructional alignment and planning. The SAT Suite can help:
 - Measure student readiness for college and career beginning in eighth grade.
 - Monitor student progress and growth over time in grades 8–12.
 - Identify areas of strength and areas for focus in curriculum and instruction.

- Vertically align curriculum.
- Develop cross-subject tasks and assignments.
- Focus interventions for students who need to work on skills.
- The minimum and maximum scores vary from assessment to assessment to show the difference in complexity of knowledge on the different tests. Theoretically, if a student were to take the PSAT 8/9, PSAT 10, and SAT on the same day, he or she would score the same on each assessment, but if the student scored "perfectly" on all three, he or she would only score a 720 on PSAT 8/9, compared with a 760 on the PSAT/NMSQT, compared with an 800 for Math on the SAT. This is because the difficulty of questions is greater on the SAT.
- Total Score and Section Scores Each of the assessments in the SAT Suite reports a total score that is the sum of two section scores: Evidence-Based Reading and Writing, and Math. Scores for the SAT Essay are reported separately and are not part of a student's total SAT score.
- Ranges for **Total Scores**
 - SAT: 400–1600
 - PSAT/NMSQT and PSAT 10: 320–1520
 - PSAT 8/9: 240–1440
- Ranges for Section Scores (Evidence-Based Reading and Writing, Math)
 - SAT: 200–800
 - PSAT/NMSQT and PSAT 10: 160–760
 - PSAT 8/9: 120–720
- **Test Scores.** Each assessment reports three test scores: the Reading Test score, the Writing and Language Test score, and the Math Test score. Ranges for Test Scores (Reading, Writing and Language, Math)
 - SAT: 10–40
 - PSAT/NMSQT and PSAT 10: 8–38
 - PSAT 8/9: 6–36
- Cross-Test Scores. Each of the assessments reports two cross-test scores: Analysis in History/Social Studies and Analysis in Science. These scores are based on questions in the Reading, Writing and Language, and Math Tests that ask students to think analytically about texts and problems in these subject areas. Ranges for Cross-Test Scores (Analysis in History/Social Studies, Analysis in Science)
 - SAT: 10–40
 - PSAT/NMSQT and PSAT 10: 8–38
 - PSAT 8/9: 6–36

- **Subscores**. The assessments report multiple subscores for Reading, Writing and Language, and Math, all ranging from 1 to 15 points. Subscores provide more detail about student achievement. The Reading Test and the Writing and Language Test each contribute questions to two subscores:
 - Command of Evidence
 - Words in Context
 - The Writing and Language Test also reports two additional subscores:
 - Expression of Ideas
 - Standard English Conventions
 - The Math Test reports three subscores:
 - Heart of Algebra
 - Problem Solving and Data Analysis
 - Passport to Advanced Math (SAT, PSAT/NMSQT, and PSAT 10 only)
- Educator Access to Student Results. To support the alignment of curriculum and assessments, the online portal includes links to California state standards.
- Provides teachers and curriculum specialists with additional tools for analyzing strengths and weaknesses in curriculum and instruction. Available reports are:

Bulk Registration

Sites should request Bulk Registration as early as possible. Bulk registration labels are available on a first-come, first-served basis to up to 600 U.S. schools. Bulk registration cannot be requested until the schools' PSAT/NMSQT order is placed. Schools are encouraged to place their preliminary PSAT/NMSQT as early as possible. The bulk registration fee is \$100 per grade level.

Benefits of bulk registration:

- Improves data accuracy: Data submitted by schools, districts, and states are often more accurate, making them more useful.
- Reduces billing discrepancies: Contract billing is based on grade level. Using districtsubmitted data eliminates the issues caused by students bubbling in the wrong grade or not bubbling in any grade.

- Saves time on test day: Bulk registration reduces the time students spend filling out registration information on test day, allowing them to focus on the test.
- The date your labels arrive depends on when you submit your data. The Bulk Registration Timeline will be available soon (upload deadlines tend to be in August prior to the October administration)

Implementation

- 1. All district students in grade 10 are expected to take the PSAT/NMSQT on Wednesday, October 10, 2018.
- 2. Sites must order their school's tests online at http://www.collegeboard.com/school/.
- 3. Important PSAT/NMSQT Deadlines:
 - a. **Friday, June 29, 2018**: **Deadline** to request 11th grade fee waivers. After thiFs date, a limited number of additional fee waivers will be available on a first-come, first-served basis.
 - b. **Friday, June 29, 2018: Deadline** for early ordering. Schools that order by this date will get the PSAT/NMSQT Student Guide by mid-September.
 - c. Wednesday, August 15, 2018: Deadline for schools to order tests using the preadministration option. Participating schools receive answer sheets and coordinator manuals by September 12.
 - d. **Tuesday, August 21, 2018:** Deadline to complete testing accommodations requests for Students with Disabilities (SSD).
 - e. Wednesday, September 12, 2018: Deadline for U.S. schools and districts to order, increase, or decrease PSAT/NMSQT test materials.
 - f. Wednesday, September 12, 2018: Deadline for U.S. schools to order PSAT/NMSQT accommodated test materials.
 - g. **Thursday, October 11, 2018:** Deadline to return answer sheets from the October 10 administration
 - h. **Early January 2019:** Deadline to complete online remittance and fee-waiver roster on PSAT Test Ordering website.
- 4. PSAT/NMSQT exams cost \$16.00 each. Sites can request fee waivers for eligible grade 11 students. Each site must cover the cost of PSAT/NMSQT tests for its students in grades 9, 11, and 12. Grade 11 students who qualify for free and reduced lunch are considered incomeeligible and are eligible to receive a fee waiver that will cover the \$16.00 exam fee. School sites are responsible to request fee waivers by the fee waiver deadline, Friday, June 29, 2018.

- 5. Students with disabilities who want to test with accommodations must request them from the College Board. The request process can take seven weeks and does not begin until all required documentation is received.

Payment

The College Board will generate an invoice for PSAT/NMSQT exams for students in grades 9, 11 and 12. School sites will make payments by following these directions:

- 1. Collect PSAT/NMSQT exam payment from students. **No post-dated checks will be accepted**. Payment plans must be invoiced in the Blue Bear system and payment collected monthly. An aging of outstanding balances needs to be reviewed monthly and should have a zero balance before the end of the fiscal year.
- 2. Deposit amount collected from students into your site ASB Trust Fund (PSAT Fees).
- 3. Submit and approve a requisition for the full amount of all exams at your site by **Friday**, **September 28**, **2018**. Creation of the requisition should be created as a lot order for the estimated amount for all PSAT/NMSQT exams. Use the following budget string on your requisition XXXX-90101-00-4503-1000-1110-01000-0000.
- 4. Process the remittance invoice on the College Board PSAT ordering website in December. You will have until early January to complete this process.
- 5. You will receive the final invoice at the end of January early February.
- 6. Send an email with an attached electronic copy of the PSAT/NMSQT Exam invoice to Distribution Services, supctrec@sandi.net. The subject of the email should read "College Board PSAT Exams" and the body should read "Services have been rendered. OK to pay purchase order #XXXXX." Please Cc Celeste Gutierrez and Reuben Harris on this email.
- 7. Submit the original PSAT/NMSQT invoice to your Accounts Payable Specialist (Celeste Gutierrez, Ed Center Room 3141) along with your requisition/P.O. number. **Payments should not be made from the ASB accounts directly to the PSAT exam provider.**
- 8. To deposit the amount collected from students from your ASB Trust Fund (PSAT Fees) into your site budget string, cut a check and complete the 2018-19 San Diego Unified PSAT Cashier Deposit Form (Attachment 1) and send the deposit form and check through school mail to the Cashier (Ed Center Room 3251).
